- 1. President Diane Gilbert called the Meeting to order at 1:33 p.m.
- 2. Approval of Minutes of the October 15, 2023 Meeting

Ernest Fisher presented a motion to accept the Minutes as submitted and seconded by Sue Guiducci, passing unanimously.

#### 3. Nominations and Vote for Slate of Officers and Directors

The slate of officers and directors with term expiration dates was presented for the coming year. There were no terms expiring to be considered during this annual meeting. Asking for nominations from the floor, Peggi Medeiros volunteered for re-election with her nomination moved by Ruth Furman and seconded by Kerri Santos, passing unanimously. With that, the nominations and votes were closed.

#### 4. President/Treasurer's Report

Diane Gilbert reported on DHPT's financials for the CY 2023 and YTD 2024 and DHPT's plans and achievements in the past year. She included a review of DHPT's commitments and accomplishments since DHPT took over the property as its stewards of the 1762 Akin House in 2007. DHPT's priority is to keep the property well-maintained. Environmental problems such as water and moisture saturation pose a challenge to the building's viability and longevity which will be addressed in 2025. She added that DHPT's website is being upgraded with a planned launch of early January 2025. Approved by the Massachusetts Historical Commission in perpetuity. \*\*\*DHPT received \$2,500 from the Massachusetts Cultural Council and \$44,104 from a charitable bequest. Of this bequest, \$30,000 was allocated to the Wamsutta Club/James Arnold Mansion, Inc. and \$14,404 was allocated to DHPT for preservation uses.

#### **Accomplishments 2024-2025**



- Held Akin House Tour with Holiday Wreaths sale the Saturday after Thanksgiving (November 30, 2024) as fundraiser to benefit Troop 13G.
- "Never Idle Hands—Living in Early America" at the Akin House on June 28-29, 2025. Overnight militia encampment re-enacting Revolutionary War camp life. Hosted new and returning participants, including a "coffee house," tin smithing, bow and arrow crafting, and a colonial chocolate-making demonstration.
- Conducted House Tours at the Akin House upon request and by appointment.
- In January 2025, an upgraded and improved website was launched. www.dhpt.org
- Received a one-time bequest from a Westport resident for \$44,104 with stipulation to be used for preservation work only, divided between the Wamsutta Club/James Arnold Mansion, Inc. (\$30,000) and DHPT (\$14,104).

#### Looking Ahead 2025–2026





Plan and deliver living history programs with partner organizations. Participate with the communities who were originally "Olde Dartmouth" for research, events, and programs to commemorate the 250<sup>th</sup> anniversary milestones of the Revolution.

- Continue to assess and implement solutions to manage the climate and environmental conditions of the Akin House to be historically faithful to an 18<sup>th</sup> century house. Interior storm windows installed. Implement CPA-funded water and moisture mitigation project in the cellar to manage flooding and moisture wicking effect. Ongoing maintenance as needed.
- "Never Idle Hands-Living in Early America" and during Revolutionary Times. Plans underway with details to be determined. [Scheduled sometime in June 2026]
- Akin House Tour Saturday after Thanksgiving in Partnership with Scout Troop 13G.
   Sale of Holiday Wreaths on November 29, 2025 from 9 a.m. to 2 p.m. or until wreaths are sold to benefit the Scouts.





#### **Featured Presentation**

Lee McColgan, author of A HOUSE RESTORED,
The TRAGEDIES and TRIUMPHS of SAVING a NEW ENGLAND COLONIAL





"Trading the corporate ladder for a stepladder," Lee started as a neophyte, with thoughts of "how hard can it be?" to becoming a "jack of all trades." The historic preservation muse took over in a matter of months leaving investment banking in the dust.

Lee McColgan, founder of a preservation contracting company, has worked on Boston's Old North Church, Louisa May Alcott's Orchard House, and other historic buildings. His work has appeared in the pages of Architectural Digest, Boston Globe, and Wall Street Journal, with this book favorably reviewed by the New York Times. Lee has demonstrated traditional woodworking techniques on Houses with History on HGTV and Discovery+. He sits on the board of the Pembroke Historical Society and belongs to various preservation organizations.
